

TERMS AND CONDITIONS OF THE PREMIUM SALE „SQUEEZE AS MUCH AS YOU CAN OUT OF SUMMER” (hereinafter "Regulations")

§ 1 GENERAL PROVISIONS

1. The organizer of the promotion called "Squeeze out of the summer as much as possible", hereinafter referred to as the "Promotion", is VERSIM S.A. with headquarters in Poznań, at ul. Jasielska 10, NIP: 779-22-61-859, hereinafter referred to as the "Organizer".
2. The aim of the Promotion is to promote the certified training of Extreme Networks (hereinafter: "Promotional Products"), offered by the Organizer as part of the Authorized Training Center.
3. The duration of the Promotion covers the period from July 15, 2021 to August 31, 2021.
4. The promotion is organized online on the website www.versimatp.com and is open to all people who want to take advantage of the certified training offer by the Organizer and indicated in the training calendar on the website www.versimatp.com.
5. Participation in the promotion is completely voluntary.

§2 RULES OF THE PROMOTION

1. To participate in the promotion, you must purchase at least one certified training available in the Versim ATP training calendar (<http://versimatp.com/events/list/>), scheduled for the period from July 15, 2021 to August 31, 2021.
2. The purchase of one certified training, which will be organized during the promotion period, i.e. from July 15, 2021 to August 31, 2021, results in receiving a virtual rebate voucher authorizing the purchase of another training organized in the period from September 1, 2021 to December 31, 2021 year with a 5% discount.
3. The purchase of two certified training courses organized during the promotion period, i.e. from July 15, 2021 to August 31, 2021, results in the Organizer receiving a virtual rebate voucher authorizing the purchase of another training organized in the period from September 1, 2021 to December 31, 2021 with 10% discount.
4. The purchase of three certified training courses, organized during the promotion period, i.e. from July 15, 2021 to August 31, 2021, results in the Organizer receiving a virtual rebate voucher authorizing the purchase of another training organized in the period from September 1, 2021 to December 31, 2021 with 15% discount.
5. Discounts do not add up.
6. Certified training under the promotion can be purchased by both a private person and a company for their representatives / employees / customers.
7. Vouchers will be sent to the persons to whom they will be granted, by e-mail to the address provided in the training application form.

§3 TERMS OF PARTICIPATION AND PROMOTION

1. The promotion is intended for natural persons as well as legal entities, public institutions, regardless of the country they come from and where they operate.
2. The Organizer's employees are excluded from participation in the Promotion.
3. Participation in the Promotion and providing data related to the participation is voluntary.
4. In order to take part in the Promotion and obtain a Voucher, the Participant should during the Promotion:



- purchase one of the certified training courses planned for the period from July 15, 2021 to August 31, 2021 via the website www.versimatp.com
 - pay in full the cost of the purchased training,
 - read the information clause regarding the GDPR on our website and subscribe to the newsletter (necessary to send the Voucher): <http://versimatp.com/newsletter/>
 - confirm receipt of the Voucher by e-mail.
5. Performing the activities listed in par. 4 will constitute the Participant's application for the Promotion (hereinafter "Application").
 6. Vouchers cannot be exchanged for a cash amount.

§4 COMPLAINT PROCEDURE

1. Any complaints regarding the manner of conducting the Promotion may be submitted by the Participants in writing by sending a complaint by registered mail to the Organizer's address.
2. A written complaint should include the name, surname and exact address of the Participant as well as a detailed description and justification of the complaint.
3. Complaints will be considered by the Organizer within 7 (seven) days from the date of their receipt.
4. The participant will be notified of the method of considering the complaint by registered mail, sent to the address provided in the complaint within 7 (seven) days from the date of considering the complaint.

§5 PROCESSING OF PERSONAL DATA

1. Promotion participants, by providing personal data, consent to their processing by VERSIM S.A. with headquarters in Poznań, at ul. Jasielska 10, in accordance with the Act of August 29, 1997 on the protection of personal data.
2. The administrator of personal data obtained as a result of the Promotion is VERSIM S.A. with headquarters in Poznań, at ul. Jasielska 10.
3. Each Participant has the right to access and correct their data. Providing data is voluntary.

§6 FINAL PROVISIONS

1. These Regulations are available at the Organizer's office and on the website www.versimatp.com
2. The organizer reserves the right to amend these Regulations at any time without giving any reason. However, changes to the regulations may not infringe the rights acquired by the Participants.
3. In matters not covered by these regulations, the provisions of the Civil Code shall apply.
